

MASS DISINFECTION EXERCISE IN ALL THE EIGHTEEN (18) MUNICIPAL AND DISTRICT ASSEMBLIES IN THE VOLTA REGION ON SATURDAY, 4TH APRIL, 2020

Good morning Ladies and Gentlemen of the Press.

On behalf of His Excellency the President of the Republic of Ghana, Nana Addo Dankwa Akufo-Addo, the Ministry of Local Government and Rural Development, the Volta Regional Co-ordinating Council (VRCC), the Municipal and District Assemblies and on my own behalf we have invited you here this morning at very short notice to brief you on the Mass Disinfection Exercise directed by the President in all the sixteen (16) Regions of the Country and in particular the Volta Region to prevent and contain the spread of COVID-19 Pandemic.

First of all I would like to highly commend you for responding to our invitation in spite of the very short notice.

Once again your responsiveness is a reflection of the very cordial working relationship the VRCC has with the Press which has contributed significantly to the general development of the Region. Thank you so much.

As you are already aware the Mass disinfection exercise has commenced in earnest throughout the country and so far a number of region have already successfully undertaken theirs including the Greater Accra Region, the Ashanti Region, and the Bono Region among others.

Happily, the exercise has been scheduled to take place in the Volta Region on Saturday, 4th April, 2020 from 5:00 am to 2:00 pm.

For the avoidance of doubt the exercise will simultaneously take place in the major markets in all the eighteen (18) Municipal and District Assemblies in the Region.

In addition all the Lorry Parks and Shops, Stores, Restaurants, Chop Bars, and all Businesses that Operate adjacent or close to the various markets will be affected and therefore will all remain closed on Saturday, 4th April, 2020 from 5:00 am to 2:00 pm.

For the purposes of clarity we attach herewith the list of the affected markets and areas for the traders and other service providers who operate at these places to be notified and educated so that they comply with the directive to close their shops and stay away from them during the period the exercise will take place.

Therefore all Hon. Municipal/District Chief Executives are hereby directed to engage with the market Queens and traders as well as other service providers of the affected markets to solicit their full support and co-operation.

The exercise will be undertaken by Zoomlion group of companies and assisted by other sprayers to be mobilized by the Municipal and District Assemblies.

The other key stakeholders who will be assisting in the exercise include the Security Agencies, the Military, the Police, the Fire Service as well as NADMO and the Ambulance Service.

The Presence of the Security Agencies is to ensure that law and order prevails at the various places.

Therefore, as the Forth Estate of the Realm, we have invited the press to brief you about the impending exercise on Saturday, 4th April, 2020 and to solicit your usual support and assistance to carry the message across the length and breath of the citizenry and in particular to the market women, traders as well as all service providers who operate at the various markers to understand the importance and general benefits of the mass disinfection exercise so that they keep their shops closed on Saturday, 4th April, 2020 from 5:00 am to 2:00 pm.

On this note, Ladies and Gentlemen, I wish to once again thank you for your time, patience and prompt response to our invitation to attend this important meeting.

I will pause here and take any question for clarification.
