**RE: APPOINTMENT TO CHAIR A MINISTERIAL
COMMITTEE TO INVESTIGATE CIRCUMSTANCES THAT LED TO
THE UNFORTUNATE OCCURRENCES, AT EJURA IN THE ASHANTI
REGION, ON TUESDAY, 29TH JUNE, 2021**

Reference is being made to your office letter No. SCR/TA57/172/01 dated 2nd July, 2021 on the above subject matter.

The Committee was tasked to submit detailed report with its recommendations for appropriate action within ten (10) days, i.e. by 9th July, 2021.

The Committee arrived in Kumasi on Sunday the 4th day of July, 2021. On Monday the 5th day of July, 2021, the Committee paid a courtesy call on the Ejurahene and his elders and later visited the beavered families and some injured persons on Monday 5th July, 2021.

The Committee members requested the Ejurahene and his elders to inform and sensitize the residents especially those with relevant information to avail themselves to testify before the Committee.

4. The Ghana Police Service (two witnesses)


The Committee has scheduled to take testimonies from the following:
