Our attention has been drawn to a resolution passed yesterday at the behest of the General Secretary of the Party – Mr. John Boadu bringing finality to the impasse surrounding the compilation of the Yendi Constituency Album, in an effort to reorganize the party at all levels of the constituency.

We do acknowledge the efforts made by His Excellency the President of the Republic of Ghana through the Chief of Staff, the Alternative Dispute Resolution and Legal Committee of the party, and other leading members of the party in their efforts to address the issues surrounding the reorganization of the party for the past two (2) months without fear or favour when our concerns were given death ears by the Polling Stations and Electoral Areas Elections Committee, Constituency Elections Committee, Regional Executive Committee and the National Party.

The New Patriotic Party rooted on the Danquah-Busia-Dombo tradition was founded on the tenets of democracy and the rule of law and we are of the opinion that, in the spirit of fairness and natural justice, the decision that was arrived at yesterday’s sitting is akin to the principles of the party and breaches the rule of natural Justice as it is tilted towards favouring and protecting the Hon. Member of Parliament for Yendi; Alhaji Umar Farouk Aliu Mahama against that of the interest and sustenance of the party.





