**AND UPON HEARING** the submission of **MAXWELL KORBLA LOGAN** Counsel for and on behalf of Plaintiffs/Applicants herein;

**IT IS HEREBY ORDERED** that the Defendant herein is hereby restrained either by itself or its officers, assigns, privies, agents, workmen or anybody working under the Defendant's instructions from going ahead to implement the decision of the Defendant, dated 26<sup>th</sup> October 2022 in respect of the residential policy decision affecting continuing students of Commonwealth Hall, University of Ghana. The status quo must be maintained, as it used to be before the 26<sup>th</sup> October 2022 decision was taken.
