**APPEAL AGAINST NATIONAL'S DIRECTIVE TO HOLD AFRAM  
PLAINS SOUTH NDC PARTY PRIMARIES.**

We concern and disgruntled members of our party -the National Democratic Congress has intercepted a letter signed by the General Secretary of our party with revulsion and misgivings in which a false and malicious impression is created that the issues' bedeviling some constituencies which were earlier put on hold are largely dealt with and as a result and now being authorized to hold the Parliamentary primaries come 13th May, 2023.

We wish to state emphatically and unequivocally without any fear that the issues R Afram South constituency NDC has not been dealt with in any shape or form.

The law of Natural justice entails that everybody must be giving a **FAIR HEARING** albeit "stupid" it may sound. In the case of Afram Plains South we have sent several petitions to the 'Powers That Be' to ensure peacefully resolution of Afram Plains South issues.

In view of this, the aforementioned law enjoined the National Executives of our Party to invite us the Petitioners to the meetings or forum that sought to address our issues. Anything short of the above amount to travesty of justice. Again where there is No justice there cannot be Peace and Unity.

By this Appeal, we invoke powers of the **Functional Executive Council (FEC)** and the **Council of Elders** of our party to as matter of urgency intervene and withhold Afram Plains South Parliamentary primaries to avert the political cataclysm that is looming over the constituency.

Furthermore, the FEC MUST expunge Afram Plains South constituency from the impending Parliamentary primaries in order to protect their own integrity and that of our party the NDC as per the earlier letters issued by FEC

1. Putting the Afram Plains South constituency elections on hold
2. Annulling the illegal constituency elections. If FEC do not want the NDC PARTY to degenerate into a lawless party then they should uphold the earlier communique.

The party should NOT be disillusioned into believing that **TIME IS NOT ON OUR SIDE** therefore they want to rush things through without regard to due process and lay down, since this decision has the tendency to outlive just a Constituency Parliamentary primaries.
