REQUEST FOR INFORMATION PURSUANT TO THE RIGHT TO INFORMATION ACT, 2019 (ACT 989)

I respectfully write in my capacity as a citizen of the Republic of Ghana vested with the constitutional right to information under **Article 21(1)(f)** of the **1992 Constitution of the Republic of Ghana**. For the avoidance of doubt, Article 21(1)(f) provides that:

"All persons shall have the right to information, subject to such qualifications and laws as are necessary in a democratic society."

The implementation of this right is set out in the **Right to Information Act, 2019 (Act 989)**, with **Section 1** guaranteeing a citizen's right to information. Accordingly, I make this application pursuant to **Section 18(1)** of **Act 989**.

This request is necessitated by media reports and public discussions regarding a petition for the removal of Justice Yonny Kulendi as a Justice of the Supreme Court. In the interest of transparency, accountability, and to clarify the position of the Presidency in this matter, I respectfully request that you confirm and provide responses to the following:

1. **Whether or not a petition has been filed for the removal of Justice Yonny Kulendi as a Justice of the Supreme Court.**
2. **When was such a petition lodged?**
